

How our work comp nurse helps you

- ▶ Wendy attends office appointments with injured employee.
- ► She tracks all pertinent information on a WKC 16 industrial injury medical report from the Wisconsin Department of Workforce Development.
 - ➤ This form provides the medical documentation necessary for an employee to file a WC benefit claim in Wisconsin.
- ▶ Wendy communicates with the employee's Human Resources team to update them on:
 - > Status of patient's injury and treatment plan.
 - Communicate patient's concerns (such as not having any work to do while being on restrictions).
 - > Future appointments.
 - ▶ Restrictions on returning to work, if any.
 - ▶ Getting the patient back to work as soon as safely possible.





Common causes of work comp injuries

- Trips and/or falls
- ► Improper lifting mechanics
- Excessive repetitive use of upper or lower extremities

Many work-related injuries can be prevented.

We work closely with occupational therapists and any on-site managers to optimize on-the-job safety and work environment.

Employer's work comp Common treatment types

We have the tools, experts and experience needed to evaluate and treat any orthopedic injury or overuse condition.

Treatment goals

To return the injured employee back to work (in some sort of capacity) as soon as safely possible.

Favor conservative treatment when appropriate; surgery only when necessary.

Keep employer up to date on patient's progress, ability to work, and prognosis.

Guide successful post-injury rehab.

Non-surgical treatment options

- ▶ Injections
- ▶ Physical or occupational therapy
- ▶ Splint or brace

- ▶ Durable medical equipment (DME)
- ▶ Regenerative medicine
